I. <u>Call to order and Adoption of Agenda</u>

Dr. Lonnie Edwards convened the meeting at 6:08pm. Motion was made by Nadine Ali to adopt the Agenda, seconded by Rosa Darden Waymon. David Moskowitz had not yet arrived to the meeting. Motion passed by 6-0 vote.

II. Approval of Minutes of May 20, 2021

Motion was made by Ambreen Delawalla to approve the May 20, 2021 Minutes, seconded by Eric Mauer. David Moskowitz had not yet arrived to the meeting. Motion passed by 6-0 vote.

III. Administrative Items

A. Designation of Ethics Open Records Officer

Deputy Ethics Officer LaTonya Wiley requested approval of a Resolution designating the Ethics Administrator as the Open Records Officer, pursuant to the Ga Open Records Act. The floor was opened for discussion.

Motion was made by Nadine Ali to approve the Resolution with the designation being the office of "Ethics Administrator", and authorize the signature by the Board Chair, seconded by Ambreen Delawalla. David Moskowitz had not yet arrived to the meeting. Motion passed by 6-0 vote.

B. Presentation of Education Vendor Reviews

Ethics Officer Stacey Kalberman provided information on comparison of Educational vendors, Navex and LRN. The floor was opened for discussion.

Motion was made by Nadine Ali to enter in to a 4year contract with Navex with additional language to satisfy state law and subject to Board review, seconded by Eric Mauer. David Moskowitz had not yet arrived to the meeting. Motion passed by 6-0 vote.

C. Discussion of Rescission of Advisory Opinion re: former Commissioner Gregory Adams [2017-3]

Deputy Ethics Officer LaTonya Wiley made a presentation to the Board regarding the need to rescind Advisory Opinion No. 20107-3 as a result of the Board's dismissal of Ethics Case No. 2018-4 on April 15, 2021.

Motion was made by David Moskowitz to Rescind the advisory opinion based on prior discussion, seconded by Ambreen Delawalla. Motion passed by unanimous vote.

D. RFQ for New Board Counsel

Deputy Ethics Officer LaTonya Wiley made a presentation to the Board for the need for a Request For Qualifications for outside counsel to replace current outside counsel, Gene Chapman, due to his announced resignation . The floor was opened for discussion.

Motion was made by Nadine Ali to approve the RFQ for outside counsel, with in-house administration of the process, seconded by David Moskowitz. Motion passed by unanimous vote.

1. Malcolm Whichard v. Ozell Hayes/Rashad Cash [2021-4]

1. Kate Watanabe v. Unknown Health Care Worker [2021-2]

Motion was made by Rosa Darden Waymon, seconded by David Moskowitz, to dismiss this complaint due to lack of jurisdiction and statute of limitations. Motion passed by unanimous vote.

2. Anonymous v. Lorraine Cochran-Johnson [2019-8]

Ethics Officer Stacey Kalberman summarized the complaint to the Board and explained her rationale for requesting dismissal of the complaint. The floor was opened for discussion.

Motion was made by Nadine Ali to dismiss the case based on the recommendation of the Ethics Officer, seconded by Eric Mauer. Motion passed by 6-1. Ambreen Delawalla opposed.

3. John Clark Ashton Farmer v. Wiley [2021-3]

Ethics Officer Stacey Kalberman summarized the case to the Board and explained her rationale for requesting dismissal of the complaint. The floor was opened for discussion.

Motion was made by David Moskowitz to dismiss the case, seconded by Ambreen Delawalla. Motion passed by unanimous vote.
